#### Introduction

It's important to us at The Eric Liddell Community (Company number: SC071075) (Charity number: SC003147) (ICO registration reference: Z8324979) that we are ensuring that individual's rights and personal freedoms in terms of their personal information are upheld and respected at all times. The following privacy policy will enable you to feel confident that The Eric Liddell Community is being transparent and accountable.

# 1. Important information and who we are

### Purpose of this privacy policy

This privacy policy aims to give you information on how The Eric Liddell Community collects and processes your personal data through your use of this website, including any data you may provide through this website when you sign up to our newsletter, apply for a volunteering position or make a donation online.

This website is not intended for children and we do not knowingly collect data relating to children.

It is important that you read this privacy policy together with any other privacy policy or fair processing policy we may provide on specific occasions when we are collecting or processing personal data about you so that you are fully aware of how and why we are using your data. This privacy policy supplements other notices and privacy policies and is not intended to override them.

## Controller

The Eric Liddell Community is the controller and responsible for your personal data (collectively referred to as "we", "us" or "our" in this privacy policy).

## Changes to the privacy policy and your duty to inform us of changes

We keep our privacy policy under regular review.

It is important that the personal data we hold about you is accurate and current. Please keep us informed if your personal data changes during your relationship with us.

### **Third-party links**

This website may include links to third-party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third-party websites and are not responsible for their privacy statements. When you leave our website, we encourage you to read the privacy policy of every website you visit.

## 2. The data we collect about you

Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

We may collect, use, store and transfer different kinds of personal data about you which we have grouped together as follows:

- **Identity Data** includes first name, maiden name, last name, username or similar identifier, marital status, title, date of birth and gender.
- Contact Data includes address, email address and telephone numbers.
- Financial Data includes bank account and payment card details.
- Transaction Data includes details about payments to and from you and other details of products and services you have purchased from us.
- **Technical Data** includes internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access this website.
- **Profile Data** includes your username and password, donations made by you, your interests, preferences, feedback and survey responses.
- Usage Data includes information about how you use our website, products and services.
- Marketing and Communications Data includes your preferences in receiving marketing from us and our third parties and your communication preferences.

We also collect, use and share **Aggregated Data** such as statistical or demographic data for any purpose. Aggregated Data could be derived from your personal data but is not considered personal data in law as this data will **not** directly or indirectly reveal your identity. For example, we may aggregate your Usage Data to calculate the percentage of users accessing a specific website feature. However, if we combine or connect Aggregated Data with your personal data so that it can directly or indirectly identify you, we treat the combined data as personal data which will be used in accordance with this privacy policy.

We do not collect any **Special Categories of Personal Data** about you without your consent (this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health, and genetic and biometric data). Nor do we collect any information about criminal convictions and offences.

### If you fail to provide personal data

Where we need to collect personal data by law, or under the terms of a contract we have with you, and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into

with you (for example, to provide you with goods or services). In this case, we may have to cancel a product or service you have with us but we will notify you if this is the case at the time.

### 3. How is your personal data collected?

We use different methods to collect data from and about you including through:

- **Direct interactions.** You may give us your Identity, Contact and Financial Data by filling in forms or by corresponding with us by post, phone, email or otherwise. This includes personal data you provide when you:
  - apply to become a member with us;
  - subscribe to our service or publications;
  - request marketing to be sent to you;
  - enter a competition, promotion or survey; or
  - give us feedback or contact us.
- Automated technologies or interactions. As you interact with our website, we will automatically collect
  Technical Data about your equipment, browsing actions and patterns. We collect this personal data by
  using cookies and other similar technologies. Please see our cookie policy <u>Cookie Policy Eric Liddell</u>
  <u>Development</u> for further details.
- Third parties or publicly available sources. We will receive personal data about you from various third parties and public sources as set out below:
  - Technical Data from analytics providers such as Google based outside the UK.
  - Contact, Financial and Transaction Data from providers of technical, payment and delivery services such as JustGiving based inside the UK.
  - Identity, Contact and Marketing and Communications Data from providers such as VOCAL Edinburgh based inside the UK.

### Visitors to the website

When you visit our website your details are not identifiable in any way to us, we use a third party service, Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. This helps us to consider the type of information visitors are interested in. We use a third party to support us with the maintenance of our website, this company does not have access to any personal data.

## **Volunteering applications**

When you apply for a volunteering position with us via our online application process, your personal information gathered for recruitment purposes is forwarded to our administrative team, who then forward this onto the volunteer coordinator. Your information is not held on the website and is deleted and destroyed within a reasonable timeframe if you are not successful in your application and no relevant vacancies become available in this time period.

#### **Donations online**

Thank you for considering a donation to us. All online donations are made via JustGiving, your information is held by JustGiving in accordance with their privacy policy. Please consult this when donating.

### **Newsletter subscriptions**

When you subscribe to receiving newsletters from us, your email address is sent to our administrative team, who store your email address, with no other personal data, for the purposes of sending you a digital version of our newsletters. To unsubscribe please email with the heading "Unsubscribe Newsletter" to info@ericliddell.org and it will be removed from our files.

#### **Visitors to our Community:**

#### **Closed Circuit Television**

CCTV is in operation at the entrance of The Eric Liddell Community and five other locations in the building, these images are recorded for security purposes and are held for 1 month, on the digital recorder's hard drive. These images are not shared with third parties, unless an incident is reported to the police or our insurers. Privacy notices are in place within the Community to ensure that all users of the Community are aware that their images are being recorded.

# Signing in book

Staff and visitors are required to sign in to The Eric Liddell Community signing in sheets at reception on entering and exiting the building. In the event of a fire or emergency evacuation, this list would be handed to the fire marshall/fire officers, who will use this as a basis for checking if anyone has potentially been left in the building. The sheets are disposed of at the end of each day.

### People who contact us via social media

We manage all our social media in house and therefore do not use a third-party provider to look at our interactions.

If you send us a private or direct message via social media, the message will be stored in accordance with Facebook/Twitter's privacy policy. It will not be shared with any other organisations. The Eric Liddell Community may provide a contact email address or phone number in response depending on the nature of your message. However, please refer to Facebook/Twitter's privacy policies before sending any messages if you have any concerns.

# People who call our Front desk

When you call The Eric Liddell Community front desk, reception does not digitally store caller information. We will forward your call to the appropriate person or email your query to the appropriate The Eric Liddell Community team member. Please see the email notice below.

### People who email us

We welcome email contact from anyone interested in the work The Eric Liddell Community does. We hold onto email correspondence for the limit of time the query of response takes to be completed. We regularly monitor our email in and sent boxes and delete emails on a regular basis.

We will monitor any emails sent to us, including attachments, for viruses or malicious software. Please be aware that you have a responsibility to ensure that any email you send is within the bounds of the law.

## People who make a complaint to us

The Eric Liddell Community is always open to improving our services and treat comments and complaints with the sensitively and consideration they deserve. When we receive a complaint from a person we make up a file containing the details of the complaint. This normally contains the identity of the complainant and any other individuals involved in the complaint.

We will only use the personal information we collect to process the complaint and to check on the level of service we provide. We do compile and publish statistics showing information like the number of complaints we receive, but not in any way that would identify anyone.

We will keep personal information contained in complaint files in line with our complaints policy. This means that information relating to a complaint will be maintained and made available for inspection by those duly authorised to do so. Complaints files will be retained in accordance with clause 8.

## People who use The Eric Liddell Community services

The Eric Liddell Community offers various services to the public.

We hold the details of the people who have requested the service. However, we only use these details to provide the service the person has requested and for other closely related purposes.

## Job applicants, current and former ELC employees

The Eric Liddell Community is the data controller for all the information you provide during the recruitment process unless otherwise stated. If you have any queries about the process or how we handle your information, please contact us at info@ericliddell.org

#### 4. How we use your personal data

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform the contract we are about to enter into or have entered into with you.
- Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal obligation.

Generally, we do not rely on consent as a legal basis for processing your personal data although we will get your consent before sending third party direct marketing communications to you via email or text message. You have the right to withdraw consent to marketing at any time by contacting us.

## **LAWFUL BASIS**

Legitimate Interest means the interest of our business in conducting and managing our business to enable us to give you the best service/product and the best and most secure experience. We make sure we consider and balance any potential impact on you (both positive and negative) and your rights before we process your personal data for our legitimate interests. We do not use your personal data for activities where our interests are overridden by the impact on you (unless we have your consent or are otherwise required or permitted to by law). You can obtain further information about how we assess our legitimate interests against any potential impact on you in respect of specific activities by contacting us.

**Performance of Contract** means processing your data where it is necessary for the performance of a contract to which you are a party or to take steps at your request before entering into such a contract.

**Comply with a legal obligation** means processing your personal data where it is necessary for compliance with a legal obligation that we are subject to.

# Purposes for which we will use your personal data

We have set out below, in a table format, a description of all the ways we plan to use your personal data, and which of the legal bases we rely on to do so. We have also identified what our legitimate interests are where appropriate.

Note that we may process your personal data for more than one lawful ground depending on the specific purpose for which we are using your data. Please contact us if you need details about the specific legal ground we are relying on to process your personal data where more than one ground has been set out in the table below.

### Marketing and promotional offers

#### Third-party marketing

We would never share your personal data with any third party for marketing purposes without your prior consent.

#### **Cookies**

You can set your browser to refuse all or some browser cookies, or to alert you when websites set or access cookies. If you disable or refuse cookies, please note that some parts of this website may become inaccessible or not function properly. #### Change of purpose

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose. If you wish to get an explanation as to how the processing for the new purpose is compatible with the original purpose, please contact us.

If we need to use your personal data for an unrelated purpose, we will notify you and we will explain the legal basis which allows us to do so.

Please note that we may process your personal data without your knowledge or consent, in compliance with the above rules, where this is required or permitted by law.

# 5. Disclosures of your personal data

We may share your personal data with the parties set out below for the purposes set out in the table *Purposes for which we will use your personal data* above.

# **External Third Parties**

- Professional advisers including lawyers, bankers, auditors and insurers based in the UK who provide consultancy, banking, legal, insurance and accounting services.

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

#### 6. International transfers

We do not transfer your personal data outside the UK.

# 7. Data security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

#### 8. Data retention

### How long will you use my personal data for?

We will only retain your personal data for as long as reasonably necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, regulatory, tax, accounting or reporting requirements. We may retain your personal data for a longer period in the event of a complaint or if we reasonably believe there is a prospect of litigation in respect to our relationship with you.

To determine the appropriate retention period for personal data, we consider the amount, nature and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal, regulatory, tax, accounting or other requirements.

By law we have to keep basic information about our customers (including Contact, Identity, Financial and Transaction Data) for six years after they cease being customers for tax purposes.

In some circumstances you can ask us to delete your data: see *your legal rights* below for further information.

In some circumstances we will anonymise your personal data (so that it can no longer be associated with you) for research or statistical purposes, in which case we may use this information indefinitely without further notice to you.

#### 9. Your legal rights

Under certain circumstances, you have rights under data protection laws in relation to your personal data.

You will not have to pay a fee to access your personal data (or to exercise any of the other rights). However, we may charge a reasonable fee if your request is clearly unfounded, repetitive or excessive. Alternatively, we could refuse to comply with your request in these circumstances.

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that personal data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response.

We try to respond to all legitimate requests within one month. Occasionally it could take us longer than a month if your request is particularly complex or you have made a number of requests. In this case, we will notify you and keep you updated.

# You have the right to:

- Request access to your personal data (commonly known as a "data subject access request"). This enables
  you to receive a copy of the personal data we hold about you and to check that we are lawfully processing
  it.
- Request correction of the personal data that we hold about you. This enables you to have any incomplete
  or inaccurate data we hold about you corrected, though we may need to verify the accuracy of the new
  data you provide to us.
- Request erasure of your personal data. This enables you to ask us to delete or remove personal data where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your personal data where you have successfully exercised your right to object to processing (see below), where we may have processed your information unlawfully or where we are required to erase your personal data to comply with local law. Note, however, that we may not always be able to comply with your request of erasure for specific legal reasons which will be notified to you, if applicable, at the time of your request.
- Object to processing of your personal data where we are relying on a legitimate interest (or those of a
  third party) and there is something about your particular situation which makes you want to object to
  processing on this ground as you feel it impacts on your fundamental rights and freedoms. You also have
  the right to object where we are processing your personal data for direct marketing purposes. In some
  cases, we may demonstrate that we have compelling legitimate grounds to process your information
  which override your rights and freedoms.
- Request restriction of processing of your personal data. This enables you to ask us to suspend the processing of your personal data in the following scenarios:
  - o If you want us to establish the data's accuracy.
  - o Where our use of the data is unlawful but you do not want us to erase it.
  - Where you need us to hold the data even if we no longer require it as you need it to establish, exercise or defend legal claims.
  - You have objected to our use of your data but we need to verify whether we have overriding legitimate grounds to use it.
- Request the transfer of your personal data to you or to a third party. We will provide to you, or a third
  party you have chosen, your personal data in a structured, commonly used, machine-readable format.
  Note that this right only applies to automated information which you initially provided consent for us to
  use or where we used the information to perform a contract with you/
- Withdraw consent at any time where we are relying on consent to process your personal data. However, this will not affect the lawfulness of any processing carried out before you withdraw your consent. If you withdraw your consent, we may not be able to provide certain products or services to you. We will advise you if this is the case at the time you withdraw your consent.
